 - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
 - c. a reference to a person includes firms, companies, government entities, trusts and partnerships:
 - d. "including" is understood to mean "including without limitation":
 - $e.\ reference\ to\ any\ statutory\ provision\ includes\ any\ modification\ or\ amendment\ of\ it;$
 - f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

3. This privacy policy applies only to the actions of Express Reinforcements Limited and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.



4. For purposes of the applicable Data Protection Laws, Express Reinforcements Limited is the "data controller". This means that Express Reinforcements Limited determines the purposes for which, and the manner in which, your Data is processed.

Data collected

- 5. We may collect the following Data, which includes personal Data, from you:

How we collect Data

- 6. We collect Data in the following ways:
 - a. data is given to us by you; and
 - b. data is collected automatically.

Data that is given to us by you

- 7. Express Reinforcements Limited will collect your Data in a number of ways, for example:
 - a. when you contact us through the Website, by telephone, post, e-mail or through any other means;
 - b. when you register with us and set up an account to receive our products services;
 - c. when you make payments to us, through this Website or otherwise; in each case, in accordance with this privacy policy.

Data that is collected automatically

- 8. To the extent that you access the Website, we will collect your Data automatically, for example:
 - a. we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.
 - b. we will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the Website, see the section below, headed "Cookies".

Our use of Data

- 9. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:

- 11. When you register with us and set up an account to receive our services, the legal basis for this processing is the performance of a contract between you and us and or taking steps, at your request, to enter into such a contract.

Who we share Data with

- 12. We may share your Data with the following groups of people for the following reasons:

 - b. our employees, agents and or professional advisors to allow our staff to process your order;
 - c. relevant authorities to facilitate the detection of crime or the collection of taxes or duties ;in each case, in accordance with this privacy policy.



Keeping Data secure

- 13. We will use technical and organisational measures to safeguard your Data, for example:
 - a. access to your account is controlled by a password and a user name that is unique to you.
 - b. we store your Data on secure servers.
- 14. We conform to ISO 27001, this family of standards helps us manage your Data and keep it secure.

Data retention

Your rights

- 19. You have the following rights in relation to your Data:
